



## **AGREEMENT FOR EDUCATIONAL AND SCIENTIFIC COOPERATION**

between

**BERGISCHE UNIVERSITÄT WUPPERTAL/THE UNIVERSITY OF WUPPERTAL, GERMANY**  
**School of Human and Social Sciences**

and

**UNIVERSITY OF ZAMBIA, LUSAKA, ZAMBIA**

This institutional collaboration agreement ("Agreement") is made by and between the University of Zambia, represented by its Vice-Chancellor, Professor Luke Evuta Mumba, PhD, on behalf of its School of Education, Central Administration Block Great East Road Campus, with postal address: P.O. Box 32379, Lusaka, Zambia, and Bergische Universität Wuppertal, represented by its Rector, Prof. Dr. Dr. h. c. Lambert T. Koch, behalf of its School of Human and Social Sciences, Gauss Str. 20, 42119 Wuppertal, Germany, each a "Party" and collectively the "Parties"

Whereas the Parties have mutual interests in promoting education, exchange and research through joint activities. Now, therefore, the Parties agree as follows:

### **Article 1**

The aim of the present agreement is to define the framework in which joint actions shall be taken to promote the cooperative relations in education and research. Both parties will encourage direct contact and cooperation between their faculty members, departments and research institutes. Each institution will designate one of its members as its representative in charge of the cooperation and to develop and coordinate specific activities or programs.

The cooperation under this agreement shall include:

- Joint research activities;
- Exchange of information in the area of scientific education and research which is of mutual interest to both institutions;
- Arranging for student and faculty exchanges. Regulations concerning the exchange of students have to be provided separately in an "Supplementary Cooperation Agreement for the Exchange of Students";
- Special short-term academic, training and cultural program;
- Pursuing other mutually advantageous undertakings.

Activities shall take place according to the needs and priorities of each party.

### **Article 2**

The themes of the joint activities and the conditions for utilizing the results achieved as well as the arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific case, whenever necessary, in accordance with mutual requirements and requests.

Both parties understand that the financial arrangements will also be negotiated at each time

and will depend on the availability of funds. The partners will try to ensure financing by obtaining external funding.

### Article 3

Except in noting the existence of this agreement, no use of the name, symbols, signs or trade-marks of one university shall be used by the other unless there is a written agreement from the other part.

### Article 4

Both parties agree that the intellectual works resulting from the actions developed by the means of this agreement will become property of the part that produced them. If they are part of joint ventures both parties will share the rights. At every moment the parties will recognize the right of the researchers to be named as authors.

### Article 5

This agreement shall enter into force when duly signed by the authorized representatives of both parties and will remain in effect for five (5) years following its date of approval. Its validity may be extended after mutual consultation by written declaration. It may be terminated either by mutual agreement or by not fewer than six months' written notice from one party to the other.

This agreement is executed in English in duplicate and each party will hold one copy.

Hereupon, the signatures of the representatives of both parties will follow in the hope of promoting mutual friendship and goodwill.
